**THE PUBLIC INFORMATION VERSION OF INCIDENT REPORT.** Contains a summary of the crime, the complainant's name, address, date, time and location of the incident, the responding Officer's name(s), and the incident number. This report generally includes all the information needed by an insurance company if you need the report for a claim. Typically provided to requestor in 7 – 10 business days at no charge. Failure to select this option will result in documents being sent to Texas Attorney General for Opinion on release of relevant documents and will take approximately 60 days to complete.

**CRIMINAL OFFENSE REPORT.** Normally only available if case closed **and** conviction entered (someone was arrested, convicted and received jail/prison time and/or deferred adjudication and/or a fine) or if case closed **and** inactive. If this option is selected and the status of the case fails to meet the requirements as noted above, the request will be forwarded to the Texas Attorney General's Office for a ruling as to whether or not we can release the full report, a process which takes approximately 60 business days. Charges for copies will be billed as outlined by Texas Attorney General's Office.
